Information about your department

Are you a Political Subdivision or a Volunteer Fire Department ?

Enter your type of organization. A political subdivision is a municipality or local government such as a city, town, township, borough, village, or fire district.

A volunteer fire department is a not for profit corporation organized to provide fire fighting services for a community and is not "owned" by the local government

Full legal name:

Enter the legal name of your organization. This is the name on your charter (for political subdivision) or articles of incorporation (for volunteer fire departments).

Federal Tax ID number:

Enter the tax number assigned to you by the IRS for all financial reporting purposes. It is also called the Employer number. It will be 9 digits in format such as 12-3456789.

Contact Person:

Enter the name of the person who will be responsible for the completion of the application and the financing documents.

Title:

Enter the title (i.e., President, Treasurer, or Chief) of the Contact Person.

Email Address:

Enter the email address of the contact person. Electronic communication and suggestions and help will be sent regularly to this address. Please ensure that your email system will not block any emails from @cheapfireloans.com email addresses.

Phone Number:

Enter the best phone number to reach you (if phone contact is necessary).

Authorized Signer:

Enter the name of the person who will be authorized to sign the financing documents on behalf of your organization.

Secretary:

Enter the name of the secretary or person who keeps records and minutes of your organizations resolutions and activities.

Insurance Agent Name:

Enter the name of your insurance agent who will be contacted prior to payment of your new truck for a certificate of insurance.
